He has significant experience in overseeing large multi-state real estate projects, including mineral title projects and commercial real estate acquisitions, and has represented energy clients in connection with due diligence, sale and acquisition transactions.

### EXPERIENCE

Some of Mike's more notable legal matters include:

- Obtained state based tax incremental financing (TIF) for various projects, including multi-million dollar property tax TIF for infrastructure improvements necessary for a redevelopment project. That redevelopment project resulted in the employment of more than 170 area residents;
- Provided full range of services for a large regional redevelopment project including anchor tenant leasing, land sales, construction agreements, dispute resolution and related litigation;
- Served as counsel for surviving bank holding company in the first interstate bank merger in West Virginia;
- Served as counsel for the formation of de novo West Virginia state bank and its holding company; and,
- Obtained a Supreme Court of Appeals of West Virginia reversal and remand based on improper indictment.

Prior to joining the firm, Mike was a partner at a law firm in Wheeling, West Virginia, where he served as the leader for the land and natural resource development practice group.
